I: Welcome – Ian Sherman

III: Torah Day School of Ottawa Loan - Ian Sherman, Tal Scher & Andrea Freedman

Ian thanked the board for the robust and healthy discussion regarding a loan to Torah Day School of Ottawa at the last board meeting. He notified there are two board members who also serve on the boards of day schools and, as per past practice, Tal Scher and Leila Ages would be abstaining from the vote but would participate in the discussion.

lan, Tal and Andrea, answered all questions posed by the board regarding the document circulated ahead of the meeting. Ian then opened the floor for a more general discussion. All questions were answered to the board's satisfaction.

V: Microgrant Funding – Andrea Freedman

VI: Campus Operating Budget Presentation – Mark Gruner & Harold Feder

lan invited Mark and Harold to present the Campus Operating Budget. Mark highlighted some of the key points noted in the Operating Budget, circulated ahead of the meeting, and answered questions from board members.

Ian thanked Mark, Harold, Rena, and Tal for their work on this file and explained that, as Campus is a separate legal entity, the campus board would be voting on the budget.

VII: President's Report – Andrea Freedman

lan invited Andrea to present on the President's Report, who provided the following updates to the report previously circulated to the board:

- The event "PJ in PJs Celebrate Shabbat" was very successful and attended by 25 families (75 people);
- The "Maccabee Task Force Fact Finding Trip to Israel" is not able to happen in May but the team is working hard to recruit for a new date in August;
- The "Mission to Israel" scheduled for April has 27 Ottawans confirmed;
- Tomorrow there will be a "Momentum (JWRP) Women's Trip to Israel" information session for which 40 women have signed up; and
- There were delegations made at recent meetings at the OCDSB concerning anti-Palestinian racism. In a meeting with the Director of Education, Andrea expressed understanding of the challenge presented to them and the need to always stand against hate; and at the same time, the recent delegations risk importing a foreign geo-political conflict to schools, which is a significant concern. Federation will start one-on-one approaches with trustees to discuss the issue.

All questions were answered to the board's satisfaction.

Ian thanked Andrea for her report.
