DECLARATION OF INTENT

This form is a confidential form to be shared only with the agencies you have designated as its benefactors. This form is NOT a legal form. It simply serves as a means for the agencies to recognize and show appreciation for your stated intention to leave them a Legacy bequest.

Each agency participating in this community-wide Legacy Project has established its own processes for receiving, managing and disbursing the income from Legacy gifts they receive. If you have specific questions regarding these administrative processes, we recommend you pose those questions to the individual agencies.

The Jewish Federation of Silicon Valley is one of the agencies participating in this community-wide Legacy project. The Federation has agreed to be the facilitator for the project and, as such, will disseminate the information on this form to the agencies you named.
