

Foundation Funds

Foundation Report

On behalf of the JFNH Foundation Trustees, we present the following summary of the performance of the Foundation's assets for the fiscal year 2024-25.

The Foundation began the fiscal year on July 1, 2024, with \$4.5 million in assets, and concluded the fiscal year on June 30, 2025, with \$4.9 million in assets. During the fiscal year, the Foundation distributed \$151 thousand to support programming, activities, initiatives, and operations in furtherance of JFNH's mission.

The Foundation's assets are managed by Evanson Asset Management (EAM), an advisor that specializes in index and passive management and had over \$5 billion under management as of January 2025. EAM derives its investment strategy from academic research and makes use of passive portfolios from Dimensional Fund Advisors (DFA) and Vanguard ETF index funds, among other investments. The Foundation pays \$750 per quarter to EAM for its services. EAM has been fully managing the Foundation's assets since February 2023.

This year the Trustees began work on a planned giving program that fosters a culture of lifetime philanthropy within our New Hampshire Jewish community and encourages donors to include JFNH in their estate plans to ensure a lasting impact beyond their lifetimes.

For the third fiscal year in a row, JFNH's withdrawals from the Foundation were under budget. Thank you to JFNH Treasurer Harry Shepler and his finance committee, Executive Director Allyson Guertin and Finance Manger Tina LeMay for their continued careful management of JFNH's resources.

With abundant gratitude for her many years of dedicated service to our New Hampshire Jewish community, we say goodbye to our Executive Director, Allyson, and we wish her every success in her new role as Assistant Director of Dartmouth Hillel. We look forward to having many opportunities to collaborate with Allyson in her new role.

Please join us in welcoming back Trustee Ross Fishbein, Esq. for another term. Trustee Rich LeSavoy will be exchanging his Trustee hat for that of JFNH Board Treasurer in the coming fiscal year and will continue to serve as an ex-officio Trustee.

Establishing an endowed fund with the Foundation is easy to do and ensures that your gift will continue to support the NH Jewish Community in perpetuity. Bethlehem Hebrew Congregation - Jacki Katzman


of her dad, and singing all the prayers she learned by heart attending services with her dad. "If there's one thing I miss from my professional career, it's collaborating on team of brilliant

Temple B'nai Israel proudly selects Gloria and Irving Fox for the 2025 Shem Tov award. Born in Montreal, Gloria graduated from McGill University with a degree in psychology and sociology. She received her MEd in Special Education from UNC, Chapel Hill and taught for several years. Upon arriving in Boston in 1990, Gloria focused on art history at the Museum of Fine Arts, Boston, where she spent 34 years as a Gallery Instructor and School Group Guide.

Irving was also born in Montreal and graduated from McGill Medical School. His academic career, from 1972-2008, included the University of Toronto, University of Michigan, and Harvard Medical School, where he held appointments at Massachusetts General Hospital and Beth Israel Deaconess Medical Center.
