EDUCATION SESSIONS: Before the trip to Winnipeg, MB, attendance by students in **all** nine educational sessions (or their equivalent) is **mandatory**. Program schools/organizations will monitor class attendance. The school/organization will contact The Asper Foundation to explore the possibility of **expelling** a student from the program in the following cases: (1) If a student is absent from a class without a legitimate reason such as a personal or family emergency that has been confirmed by their parent/legal guardian; (2) If a student consistently does not exhibit a proper commitment or behaviour in the classes themselves; (3) If a program school/organization provides documented, verifiable evidence that a student is participating in any behaviour within or outside of the program that could be reasonably perceived as physical or verbal harassment including racist behaviour. Classes that have been missed by a student *for legitimate reasons only* will have to be made up to cover the material.

COMMUNITY VOLUNTEER SERVICE: Each program student must complete a **minimum** of 10 hours of legitimate volunteer service work for his/her community. Program schools/organizations will monitor the work to ensure students properly complete their requirements. Students must get approval from their program school/organization **prior** to carrying out any community volunteer service to ensure that the work they are carrying out meets the program requirements. Community volunteer service that qualifies as fulfilling the program volunteer requirements can only be carried out from the date a student is notified that they will be participating in the program until the Winnipeg, MB trip.

All volunteer services for the purpose of this program must be provided to or through a legitimate non-profit or charitable community organization or institution. Volunteer services not provided to or through a legitimate non-profit or charitable community organization or institution are not eligible towards fulfilling the program volunteer requirements. Participation in school musicals or projects and any services provided to family members or relatives of students are not eligible towards fulfilling the program volunteer requirements. *Volunteer services that are already being done by a program student (separate from the program) are not eligible towards fulfilling the program volunteer requirements.* Any other volunteer services are acceptable as long as they meet the above-noted guidelines. **Each program student must complete a Community Volunteer Service Form and provide it to his/her program school/organization. Program schools/organizations must send in Community Volunteer Service Form information to The Asper Foundation by April 3, 2018.**

MEMORANDA FOR PERSONAL RESPONSIBILITY GRADUATION CEREMONY: After the program, *if* a ceremony is held, attendance is **mandatory** unless permission to be absent for legitimate reasons has been provided to the student by their program school/organization **prior** to the ceremony.

PROGRAM FEEDBACK: Each program student will be provided with a feedback form which is private and confidential and to be completed anonymously. It will only be reviewed by representatives of The Asper Foundation and program administrators for the purpose of improving the program.

NOTE: During the Winnipeg, MB trip, students, chaperones and others participating in the program may be photographed and these photographs (without name identification) may be posted on media Web sites and on one or more of the following organization's Web sites: The Asper Foundation, The Asper Foundation Human Rights and Holocaust Studies Program, Friends of the Canadian Museum for Human Rights and Canadian Museum for Human Rights.
