THANKS TO THE INCREDIBLE GENEROSITY OF OUR DONORS, THE JEWISH FEDERATION WORKED TIRELESSLY TO MOVE OUR COMMUNITY, LOCALLY AND AROUND THE WORLD, FORWARD. IN 2023-2024, THE JEWISH FEDERATION OF GREATER PORTLAND FOCUSED ON IMPLEMENTING RECOMMENDATIONS FROM THE JEWISH COMMUNITY STUDY WHILE RESPONDING TO UNEXPECTED CHALLENGES. FOLLOWING THE EVENTS OF OCTOBER 7, THE FEDERATION MOBILIZED THE COMMUNITY, TRANSFORMING GRIEF INTO SOLIDARITY AND SUPPORT.
