Our Center for Combating Antisemitism, Saidoff Legal Department, Campus Department, and High School Department offer strategy meetings, policy analysis, legal and/or moral clarity letters to administrators and school boards, publicity campaigns, and legal education to inform both students and parents about their rights when facing antisemitism.

When necessary, we make use of available legal tools, including Title VI of the Civil Rights Act of 1964, to address unlawful antisemitic activity, especially on university campuses.
