As we said goodbye to 2025, a year beset by crises and upset by hatred, we can at least take solace in the financial and service performance of the Jewish Foundation of Greensboro. We at the Foundation have had a remarkable year, and one that we can only hope to repeat in the year to come, our thirtieth year as a Foundation.

By year end 2025, we held assets of just under \$120 million for our donors and community affiliates, and as of this writing have exceeded that milestone. A remarkable \$7.5 million were distributed to hundreds of non-profit organizations across our state and beyond, and incredibly \$10.4 million were contributed to Foundation accounts this last calendar year. As these numbers indicate, our impact is growing now and will continue to increase in the future through the hundreds of donor advised and legacy accounts established. In fact, through concerted efforts by our staff, led by Susan Gutterman, and our board, we have attracted over \$10 million in new assets this last year.

Indeed what a wonderful run we have had for thirty years. So to celebrate our success in helping to distribute almost \$130 million in charitable funds, we will be hosting a 30th Anniversary event in early November of this year and honoring Tom Sloan for his long tenure as our Investment Committee Chair Extraordinaire. We are thrilled to announce that MV Financial, our longtime investment advisor, and its President Masood Vojdani, are generously and graciously our lead sponsor for the event. Stay tuned for more details as we finalize them.

Meanwhile we have made a significant addition to our professional staff. I am happy to report that we have hired Abby Kreigsman Kleber, a remarkable individual who happens to hail from a prominent Greensboro family and has the professional experience and personal traits to serve as our new Assistant Endowment Director. In this role, she will help us administer and grow our Foundation as we strive to reach out as good stewards for our community. In particular, we are excited that Abby is returning from Charlotte to Greensboro with her family after spending years as the Assistant Vice President of Stewardship and Legacy Giving for the Charlotte Jewish Foundation, giving her unique insight into our giving philosophy and foundation principles. We look forward to introducing (or reintroducing) you to Abby as she begins her new journey.

So as we face 2026, and its great unknowns, we will hope again for a safe and prosperous new year. Thank you again for your commitment to the Jewish Foundation of Greensboro.
