

### **Chip Rayman, KJA President**

Big news for ending the year! A long-standing member of our community, Adam Brown and his family, have issued a challenge contribution to further enhance the playground in memory of his son, Logan. Kristen Cannon offered to use the Art Gala funds to start the expansion of our Preschool playground. Even though we have a Three-Star rated in all categories preschool, we get "dinged" on our playground.



Working without an Executive Director, Ed Hunter, Laura Faye Berry, and I acted as one, collectively, making decisions. Working without compensation is part of my contribution to the Knoxville Jewish Alliance.

In lieu of the Executive Director's report, please see page 5 for a partial list of achievements and investments in our people, our programs, our building and grounds.

I've attended over 100 events or meetings representing the Knoxville Jewish Alliance/Arnstein Jewish Community Center, addressed City Council about hate speech, put together a Vigil, and have spoken to the media on several occasions. I have felt the pressure of the Annual Campaign every day and have occasionally been overwhelmed, but it has been fulfilling.

We achieved over \$65,000 in payroll savings while giving our Preschool teachers a raise, causing one of them to return to us. At the same time, we are expanding our Preschool and offering infant care starting in January. This will significantly increase revenues. To do this, we had to install a fire escape. So, the payback won't be until 2020.

We greatly improved our picnic/fire pit area collectively with Camp Manitowa (each putting in \$2,500) adding team building exercises and we now call it our Team Building Park. However, we still have not developed any revenues from it though several of our Jewish institutions have used it.

Ed leased our soccer fields for the first time in three years and got the lease payment in advance.

We ended the year with "Kill Jews" on the Rock at UT in November. Hillel took the lead in addressing this issue with the University. As a result, we have increased security.

We welcome Bernard Bendriem, incoming Treasurer, and Lee Wertheim to the board.

Thank you all for your support and guidance.

- Tara Bain is our new Hillel Director. Thanks to her efforts in recruiting and organizing, 136 students have expressed an interest in Hillel at UTK. Attendance at the first two Shabbat dinners has exceeded 45. Hillel is almost totally funded through our budget.
- Jonathan Branton is our new Program Director, Pool Co-Manager, Camp Assistant Director, BBYO adviser, B'nai Tzedek administrator, Team Building instructor and marketer, and anything else we can think of for him to do. He has been extremely helpful in all aspects of our operation with suggestions, guidance and sweat equity.
- We are hiring a receptionist to greet Preschool children, parents and guests coming to the Center. This person will also help with our office and Preschool administration. Not having a "greeter" has been a source of complaints.
- We purchased a front desk for the receptionist.
- Kim Ault is our new Preschool Chef (for real, a professional chef) who will greatly improve our preschool lunches and will cater other events.
- Sherrie Price is our new Administrative Assistant.
- Sarah May is our new PJ Library/PJ Our Way Coordinator.
- We purchased two new ovens, a "hot" bar, a commercial dishwasher and washer/dryer for the kitchen. Our ovens cooked so unevenly, you could not rely on them. The dishwasher will allow us to go to dishes, saving paper goods expense, help the environment a bit and we are projecting the dishwasher will pay for itself in 18 months. The kitchen has been painted and storage shelving reorganized. Chef Kim is pleased.
- We entered into a collective project with Dan Grabel's Camp Manitowa. We constructed and improved our Team Building Park, investing \$2,500 each, with character development and team building exercises, enlarging our fire pit, repairing our fence and greatly improving the general appearance of the area.
- We achieved budgeted payroll savings through November of over \$60,000.
- We are expanding our 3-Star rated Preschool for 2019 by adding 16 students to our capacity including infant care, significantly increasing our revenues.
- We installed 8 security cameras throughout the building and grounds. Jonathan Branton installed them. What was to be a \$2,000 to \$3,000 cost became less than \$1,000 thanks to Jonathan.
- A fire escape and equipment for the new Dalet classroom is to be completed prior to December 31<sup>st</sup>. The payoff for this major expense will be in 2020.
- Ed Hunter leased our soccer fields for the first time in 3 years to AYSO.
- Privacy window tinting was installed for Preschool and facility security.
- We moved the BBYO room to the room next to the Orwitz room to facilitate expansion of the Preschool. BBG and AZA have been painting the room.
- We achieved a five year high for Milton Collins Day Camp attendance.

- PJ Library expanded to almost 150 subscribers and we added PJ Our Way at no charge. PJ Library is mostly funded through our budget and a partial rebate from the Harold Grinspoon Foundation. It is a net cost to our budget of around \$7,000.
- Jewish Family Services, expertly administered, discretely by Laura Faye Berry, created holiday gift bags for Purim, Passover, Rosh Hashanah and Chanukkah that we took to residents in our assisted living facilities and visited with them. We had 2 day trips to Violins of Hope and Chihuly exhibits, several singers, and other programming at Sherrill Hills. We've assisted several Jewish indigent members of our community with financial support.
- We repaired our damaged overhang at the front entrance.
- LED light fixtures donated by Bryan Goldberg were installed throughout the building.
- We renovated the Orwitz room with LED lighting, ceiling tiles and refurbished columns.
- We have realigned ourselves with the Jewish Federation of North America becoming a "Network" city.
- We have taken steps to expand our playground. Kristen Cannon, Preschool Director, offered the Art Gala funds toward that effort. Even though we are a 3-Star rated in all categories Preschool, we would get dinged on our inspection for the playground. This effort will continue in 2019 thanks to a generous matching contribution by the Adam Brown family.
- Archives underwent an extensive evaluation which was covered by a grant.
- Knoshville was the best ever thanks to Anna Iroff-Bailey and Alex Jordan.
- We held vigils to honor the Tree of Life Synagogue victims in Pittsburgh and to fight hate speech on the Rock at UT. An estimated 800 people of all faiths attended the vigil hosted at the AJCC and another 100 attended the campus vigil organized by Hillel at UTK students.
- We hosted a Seeds of Abraham camp week funded with donations from the Jewish community and Yassin's Falafel House.
- Ha'Kol has gone to full color. Joyce York put together a beautiful year end video to be shown at the Annual Meeting.
- Laura Faye Berry will attend the Israel P2G Partnership Leadership 2Gether program.
- The Smokin' Salmon Swim Team has over 90 participants.
- We hosted the Knoxville Opera Preview at the AJCC.
- Funds were used to bring Sylvia Gutmann, a child Holocaust survivor, to speak to the Blount County High School students. The KJA was a sponsor.
- The AJCC hosted a Torah completion and dedication.
- The Schwarzbart Gallery hosted an art exhibit by Esther Sitver.
- We marched on Martin Luther King Day.

The KJA expends approximately \$34,000 annually on the Arnstein Jewish Community Center campus to maintain the 49-year-old facility. In addition to maintaining the facility, the KJA attempts to upgrade and update the existing facility when possible by:

- Reducing expenditures where possible.
- Funding from community contributions.
- Funding from endowments.

### 2018 Capital Improvements in the amount of \$117,374 consisted of:

- Alteration to the existing preschool Infant care available in 2019
- Kitchen equipment convection ovens, dishwasher, and dining equipment
- Pool repairs and equipment pump motor, backwash system, and pool vacuum
- Team Park installation south of the pool
- Installation of recessed LED lighting in the facility
- · Gym floor refinished
- Chairs for programs and events
- Fence repairs for the Team Park and preschool playground
- Fire alarm system upgrade (required to meet code)
- Tree and brush trimming to increase usefulness of property
- Finalized the Schwarzbart Art Gallery
- Zane Jordan Memorial PJ Library and Preschool Library bookcases
- Video surveillance system for facility and campus



- Provided photos and text for "The Way We Were" feature in each Ha'Kol issue, sometimes supplemented with additional information online
- Welcomed visitors who researched our holdings
- Continued to add new clippings, documents, and photographs to existing files, biographical and organizational
- Sought and received invaluable assistance from both current and former community members to help identify persons, places, events, and times in photographs and other materials
- Welcomed new committee members Scott Hahn and Hal Manas
- Attended the Kentucky Jewish History Symposium in April with committee co-chair Michael Burnett

- Continued serially showcasing panels from the AJCC's 75<sup>th</sup> anniversary celebration of 2004 in the hallway near the Archives
- Corresponded with Albert Good, chair of JCOR's Legacy Project
- Provided several years' worth of preschool class composite photos to be displayed at the preschool/MCDC reunion held in December 2017
- Provided a photo of Harold and Joyce Diftler to be placed on tables at the Heska Amuna Kiddush the Diftlers sponsored before they moved to California
- On Mitzvah Day, in conjunction with the theme of "strengthening our roots" committee members conducted over 25 mini-interviews of community members asking them to relate their first memory of Jewish Knoxville (whether the interviewee was born here, moved here as a child, or moved here as an adult).

   Assistance Grant (for a preservation specialist from the Northeast Document Conservation Center
   {NEDCC} to come assess our collection and the building it's housed to in for preservation). Ed
   Hunter and the archivist completed a detailed questionnaire the specialist sent in advance of her
   visit. In July we welcomed the specialist for the site visit and recently received her very detailed
   report

- · upcoming events


### **Monthly**

Hillel at UTK creates a "home away from home" for its students. The KJA provides commitment to the Hillel movement through financial support with staff employment, student programming, and faculty and staff connection. In February, KJA hired Tara Bain as the Hillel at UTK Director. Tara believes the vision of Hillel at UTK is to inspire students to make an enduring commitment to Jewish life through student-led leadership, along with social, Israeli, and social justice programming. This year, Tara has prioritized creating relationships with the students. She has also strived to build strong engagement with the Vice Chancellor for Student Life office, Jewish faculty, and Campus Ministry Council members. Hillel at UTK was invited by Campus House of Prayer (CHOP) Director Gary Peacock to share space for a Shabbat dinner. Following this initial event, Gary extended an open invitation to Hillel at UTK to hold future events at CHOP. Hillel at UTK has continued to use the International House, John C. Hodges Library, and the Panhellenic Building for events and meetings throughout the year.

### **Program Highlights**

### February 2018

KJA hired UTK Hillel Director Tara Bain in a part-time position to continue inspiring UTK students to make an enduring commitment to Jewish life, learning, and Israel through student-led leadership and participation in Jewish programming.

### March 2018

Chip and Brenda Rayman, Bryan Goldberg, Wes Johnson, and Helene Sinnreich, joined 45 students and parents, KJA members attended Shabbat dinner at the AJCC for Shabbat dinner.

### **April 2018**

For Pesach, a matzo lasagna dinner was held at the AEPi House with more than 35 students in attendance, and 25 attended a Passover-friendly Shabbat at the AJCC.

A Senior Shabbat at the International House honored four graduating seniors and was attended by 30 students. The four graduates were Jacob Geltzer of Nashville, Dan Revere of Nashville, Benji Ballin of Memphis, and Jamie Shapiro of West Bloomfield, MI.

During April, Hillel at UTK rolled out their new website, www.hillelutk.org.

### May 2018

During the middle of finals, students gathered to eat and study with a bagel and kugel brunch at John C. Hodges Library.

### Summer 2018

Tara attended the Hillel International New Director Institute in Orlando, Florida, in July. Along with 100+ in attendance, solo directors attended training directed to their special campus needs. Dana Tumpowsky is a seasoned solo professional who was assigned as Tara's mentor for the next 48 months. Rabbi Danielle Leshaw, a previous solo director and current Schusterman International Center (SIC) employee, became Tara's campus support director to provide connection to Hillel International. Zoom training with SIC professionals will ensue through summer 2019.

Tara joined Rabbi Jeremy Simons, Director with Hillels of Memphis, in Nashville to meet with Ari Dubin, Vanderbilt Hillel Director, to begin relationship and discussion for Hillels of Tennessee support system and/or programming.

Sarah Brock and Parker Alperin represented Hillel at UTK's Summer Orientation sessions where 30 freshmen registered with the organization.

### August 2018

About 45 students attended a Welcome Back Shabbat dinner at the International House. Welcome bags were handed out to all freshmen, and all students received "Hillel Yeah" t-shirts.

### September 2018

Ten freshmen attended the first First-Year Students of Hillel (FYSH) meeting to ask questions of upperclassmen about their college experiences.

Area congregations welcomed students for High Holy Days services. Students continue to be grateful for this hospitality.

### **November 2018**

Tara was honored with the invocation for the UTK versus Kentucky football game.

The Senior Shabbat dinner honored upcoming graduate Jake McCoy from Nashville.

### December 2018

A bagel break allowed students to drop by to grab a bite and study together.



The more stars a program has, the better the quality of care it offers to children. Providers also receive a full report of their Environment Rating Scale observation, so they can continue to understand and address areas that need improvement. Simply by participating in the Star-Quality Program, providers show families in their communities that they are working to offer the highest-quality child care.

# **Financial Report**

### Adam Brown, KJA Treasurer

I am pleased to report that the Knoxville Jewish Alliance is in a much better position financially than we've been the last few years. Although the KJA will end the 2018 calendar year with a break-even projection, our budget committee was able to submit a very realistic budget for 2019 showing a surplus of more than \$11,000.

- **Cash Flow Crunch** Unrestricted funds continue to be tight as the aging facility and operations continue to require more of our financial resources.
- **Executive Director** We will continue to operate without an executive director for 2019 and 2020 due to current budget constraints that make it impossible.
- **Annual Campaign** The annual campaign is currently at \$228,541 on 220 gifts as of 11/20/2018. The good news is that 104 families gave increases over the previous year, including 45 new family gifts; unfortunately 25 families decreased their gifts, including a couple of "heavy hitters,", thus leaving us short of our goal of \$300,000.
- **AJCC Preschool** The Early Childhood Program is projecting a \$60,000 profit with 51 children currently enrolled at 65% capacity. The program had 61 children enrolled at this time in 2017. The Early Childhood Program profit does not reflect any occupancy costs.
- **Milton Collins Day Camp** 2018 registrations totaled 678 weeks, the largest enrollment since 2013. It reflects a \$30,000 profit and does not reflect any occupancy costs.
- **Rentals** Include the soccer fields of \$4,000 annually on a three year contract; gymnasium rental for a fencing group for \$7,000 annually; and sundry gym & room rentals of \$1,000 annually. An additional annual contract for 2019 will include Tai Chi classes for approximately \$6,000 \$7,000.
- **Wage Costs** By the end of the year, we will have approximately 67 W-2s; the smallest workforce in over 20 years. KJA is doing everything we can to cut costs.

**Bottom Line**: Unfortunately, the financial situation of the KJA is still not good, but there appears to be a bright light at the end of the tunnel, and with the changes that have been implemented, as well as the continued efforts of the staff and volunteers, it's just possible that the bright IS NOT another train.

### **Accounting Policies**

The Knoxville Jewish Alliance's (KJA) management is responsible for the accuracy and integrity of the financial reports. The financial reports contained in the annual report have been prepared in accordance with U.S. Generally Accepted Accounting Principles (GAAP) appropriate for not-for-profit organizations. In preparing the financial reports, management makes informed judgments where necessary to reflect the expected effects of events and transactions that have not been completed. The internal controls and procedures ensure that material information required to be disclosed is recorded, processed, summarized and communicated to the Executive Board and Board of Directors within the required time periods.

The KJA utilizes the accrual accounting method that provides a thorough financial reporting system to reflect the current financial position of the organization by reporting open account receivables, accrued payables and potential contingencies. The accrual method of accounting recognizes revenues when earned and expenses when incurred.

### **Presentation Basis**

The financial statements represent the organization as a whole and report the net assets as follows:

- Unrestricted net assets: free from donor-imposed restrictions.
- **Temporarily restricted net assets:** subject to restrictions for support of particular operating activities, a specified future period, or utilized to acquire long-lived assets.
- **Permanently restricted net assets:** subject to restrictions of gift instruments generally require the principal be maintained intact in perpetuity or until the occurrence of a specified event.

The KJA maintains accounts in accordance with the principles of fund accounting to ensure observance of limitations and restrictions placed on the use of resources available to the KJA.

Each year KJA is required to have independent auditors complete an audit of the financial statements and position for the organization and to file the Form 990 Federal Tax Return with the Internal Revenue Service.

### Collections

### **Knoxville Jewish Archives**

As part of its mission, the KJA is home to the Knoxville Jewish Archives, which are maintained to preserve the historical footprint and contributions of the East Tennessee Jewish community since 1796. Materials are gifted to the archives by local residents and other institutions; archived; preserved and maintained for research by academics, families, historical societies and genealogical researchers. The value of the collection is not reflected in the statement of financial position. The KJA does not purchase or sell collection items.

### **Arnold Schwarzbart Gallery**

The Gallery is a permanent home for many pieces by the artisan, Arnold Schwarzbart, a beloved community member, whose memory shall always be a blessing. The fundraising campaign provided the funds needed to construct, install, and acquire the pieces of art that are valued at \$12,875. In addition, the gallery provides other local artists to periodically display works of art for the pleasure of the Jewish community.

### **Permanently Endowed Funds**

The KJA endowment funds are held by the Knoxville Jewish Community Family of Funds, managed by the East Tennessee Foundation. The KJA receives annual distributions in the form of grants, generally limited to income from the funds. These funds are accounted for in accordance with FASB ASC 958. The majority of endowment funds have an annual spending rate of 4.5% of a twelve-quarter rolling average. Discretionary distributions of fund principal are permitted in some of the fund documents, though the intent is to be a permanent endowment. Fund balances represented as of September 30, 2018 (less any distributions made in October 2018) are \$836,036.



The KJA revenue stream largely consists of program service fees, annual campaign pledges, other contributions, AJCC Membership dues. KJA also receives funding through external grants and sundry revenues; i.e. rentals and accounting services to a community organization.

2018 Funding Sources


When funding sources fail to meet

2018 expenditures currently exceed revenues and it is projected the year will end with a deficit unless sufficient campaign contributions are received in December 2018.

The KJA facility is open 74 hours each week; totaling over 3,600 hours annually with an average cost of \$49 per hour of operation (excluding the cost of payroll).

KJA's largest expense is payroll. In 2018, we employed approximately 69 people annually based upon program needs. Our year-round staff is comprised of approximately 18 staff members; 12 for the Early Childhood program and the remaining for other programs and administrative office.









AJCC Annual Membership provides funding for the facility which has significantly declined




**AJCC Annual Membership** has fallen from 230 in 2006 to a low of 149 in 2015 with a slight rebound to 166 in 2018.

AJCC Summer Membership has fallen from a high of 89 in 2009 to a low of 42 in 2017. Summer Membership was 45 for 2018.

Membership provides funding for the facility and administrative costs. These costs are significant as indicated. Annual Campaign must support these costs at 86 cents per dollar to cover the shortfall of membership revenue.

#### **Early Childhood Programming**


(Preschool) indicates a reduction in students since 2007 through 2014.

2018 experienced a slight decrease.


## **Preschool Count & FTE**



#### Net Assets by Fund Type by Year

The Knoxville Jewish Alliance consists of three types of net assets:

- **Permanently Restricted** subject to restrictions of gift instruments generally require the principal be maintained intact in perpetuity or until the occurrence of a specified event.
- **Temporarily Restricted** subject to restrictions for support of particular operating activities, a specified future period, or utilized to acquire long-lived assets.
- Unrestricted free from donor-imposed restrictions.




In 2003 most of the Temporarily Restricted Funds were moved to the East Tennessee Foundation and are now held by the Knoxville Jewish Community Family of Funds and reported as Beneficial Interest Held by Others or Investments. Permanently Restricted have remained fairly constant while Unrestricted has significantly declined.


**Investments fluctuate** from market fluctuations, contributions and grants for programming and operations.

External Allocations became impossible after 2008 due to the inability to meet budget from lost revenues from Annual Campaign, AJCC Membership, and Programming.


### Capital Outlays by Year

To maintain the AJCC Facility, the KJA must continually invest cash to update the existing structure and grounds. Depreciation averages approximately \$34,000 annually.

KJA has expended an average of \$36,000 annually to maintain the AJCC facility.

As indicated by the chart, some years have been more and some less. Yet our AJCC facility is getting aged and in need of many more repairs than the General Fund can accommodate through the annual budget.

Chair: Vacant in 2018

The KJA continues to struggle with sufficient funding. A portion of the struggle is the lack of a campaign/fundraising chair. Historically, the Annual Campaign fundraising has been the major supporter of the Arnstein Jewish Community Center (AJCC) facility and campus.

2018 began with "Strengthening our Roots" campaign to rally community support to strengthen the KJA/AJCC, thus strengthening the Knoxville Jewish Community as a whole. A quick departure of the previous Executive Director in December 2017 and newly elected President (volunteer) / working to fill the vacuum of a working Executive Director, Chip Rayman, hit the ground running and learning.

The KJA Annual Campaign goal was set at \$300,000 for 2018; as of Strengthening Our Roots December 1, 2018, it has raised \$229,341, leaving a shortfall of \$70,659 with only 30 days left in 2018 to correct this deficit.



- Technology will simplify the traditional campaign process allowing easier methods for KJA to connect with the community and donors to contribute.
- Pacesetter Event early in 2019 to invite and encourage donors to commit early
- Event fundraising to supplement campaign revenue.
- A traditional sponsored Shabbat at the congregations to thank supporters and encourage donors.

Currently, 2019 is lacking a Campaign Chair. An organization struggling with funding has a priority of locating an experienced fundraising leader to grow the Annual Campaign. The experience of the past five years provides evidence of this fact. The Annual Campaign revenue stream was 50% over the organizational revenue stream. Over the past the Annual Campaign revenue dropped to 35% in 2014. In the past four years (2014 to 2018), the Annual Campaign revenue stream has dropped to a mere 23.7% of the KJA revenue stream.
