



Nominations are now being accepted for the Jewish Federation of Winnipeg Board of Directors. The positions available for nomination are 6 three year terms. The board will appoint 2 individuals for three year terms. Nominations will be received at the Federation offices no later than 4:00 pm on Friday, September 30, 2016.

According to by-law no 1 of the Jewish Federation of Winnipeg, the following are eligible to be candidates:

- (6) Every person
 - (a) Whose name is on the voting list on the first day of September in each year;
 - (b) Who is either not at that time a member of the Board or, if then a member of the Board, whose term will expire consequent on the current election;
 - (c) Who has been nominated for election, as hereinafter provided, is eligible to be elected as a member of the Board; and
 - (d) Who is over the age of 18 and a contributor to the CJA.

To Nominate a Candidate:

- (i) nominations must be in writing.
- (ii) nominations must be made on the official nomination form (see reverse and available at the Federation office, the Asper Jewish Community Campus and major synagogues in Winnipeg).

Note: a nomination requires five signatures and the written commitment and consent of the nominee.

The only persons who may be candidates or who may nominate candidates are those whose names are on the voting list, which may be inspected at the office of the Jewish Federation of Winnipeg, **C300-123 Doncaster Street.**
