### **Action Item Synopses and Legislators to Contact**

#### Senate

Senators Kirsten Gillibrand (D-NY) and Roy Blunt (R-MO) have written a letter to John Kelly,
 Secretary of Homeland Security, asking him to include \$50 million for the Nonprofit Security
 Grant Program in the President's budget request to Congress.

**Letter excerpt-** "As you develop President Trump's budget, we would like to request that you increase the amount of money programmed to address the wave of threats to Jewish Community Centers (JCCs) and cultural and religious institutions across the country. Synagogues, mosques and cultural centers are confronted with increasing levels of anti-Semitism, Islamophobia, bigotry, and hate, and it is therefore imperative that the amount of funding for the Nonprofit Security Grant Program (NSGP) for Fiscal Year 2018 (FY18) be fully funded at \$50 million to meet these increased threats."

COPY: I am writing to ask you to sign the bipartisan letter by Sens. Kirsten Gillibrand (D-NY) and Roy Blunt (R-MO) requesting that the Homeland Security Secretary include \$50 million for the Urban Area Security Initiative Nonprofit Security Grant Program (NSGP) in the President's budget request to Congress.

On behalf of at-risk nonprofit organizations in our community and throughout the United States, I respectfully request that you support strengthening the NSGP by signing this letter. This issue is particularly important and timely, given the recent spate of anti-Semitic bomb threats, cemetery vandalism, and other incidents throughout the United States.

Senators Gary Peters (D-MI) and Rob Portman (R-OH) have written a letter to Secretary Kelly
expressing their concern over the alarming number of bomb threats targeted at Jewish
Community Centers, synagogues, Jewish day schools, and other Jewish institutions, and urging
him to take action to address this pressing issue. So far, the letter has been signed by 73
senators, including our own Bob Corker.

**Letter excerpt-** "We are concerned that the number of incidents is accelerating and failure to address and deter these threats will place innocent people at risk and threaten the financial

viability of JCCs, many of which are institutions in their communities. Your Departments can provide crucial assistance by helping JCCs, Jewish Day Schools and Synagogues improve their physical security, deterring threats from being made, and investigating and prosecuting those making these threats or who may seek to act on these threats on the future."

#### **Urge Senator Alexander to sign**

## **House of Representatives**

Representatives Stephanie Murphy (D-FL) and Joseph Crowley (D-NY) sent a letter to federal law
enforcement agencies, asking that they step up to find and bring to justice the perpetrators of
the bomb threats and take action to prevent future threats from occurring. The letter was
signed by over 150 members of Congress representing both parties, including our own Steve
Cohen.

Letter excerpt- "We write to express our deep concern regarding the recent spate of anonymous bomb threats made via telephone against Jewish Community Centers (JCCs) across the nation. We urge the Department of Homeland Security and the Department of Justice to swiftly assess the situation and to advise Congress on what specific steps are being taken, or will be taken, to deter such threats from being made, to identify and prosecute the perpetrators for violations of federal criminal laws, and to enable JCCs to enhance security measures such as physical barriers and guards, in the event that an individual seeks to act upon these threats."
