

HOLOCAUST ESSAY CONTEST GUIDELINES 2026 (Grades 9-12) Power of Memory: Holocaust Stories and the Stories We Carry

- 1) The essay contest is open to all high school students in TN and surrounding states.
- 2) One entry per student.
- 3) All entries must be typed and double-spaced in 12-point font.
- 4) Entries may not exceed 600 words.
- 5) Entries must include name, address, phone number, e-mail address, name of school, teacher's name, and grade.
- 7) The essay should explore the following topic: The Power of Memory: Holocaust Stories and the Stories We Carry.
- 8) When thinking about this topic consider:
 - Memory keeps history alive and gives meaning to who we are today.
 - History informs us and stories transform us, influencing our values, choices, and sense of responsibility.
- 9) In your essay, explore the role of memory in both the Holocaust and your own family and include the following:
 - Select a **Holocaust victim, survivor or witness** whose story has been preserved through written testimony, oral history, artwork, music, film, or another artistic medium.
 - Explain how their story is preserved.
 - Describe how the individual's story enhances your understanding of the Holocaust.
 - Share a story (treasured memory passed down through generations or a new story being written today) from your family and discuss what this story means to you and why preserving it matters.
 - Reflect on the following in your essay: What does Holocaust storytelling accomplish? What does family storytelling accomplish? How do both shape

identity, responsibility, the transmission of values across generations, and moral courage for the future?

- 10) Idea not your own and/or quotes must be referenced.
- 11) Judging will be based on the following criteria: originality, creativity, passion, message conveyed, connection to them, accurate historical detail, and proper use of language.
- 12) First Place cash prize of \$250; Second Place cash prize of \$125. Gift cards for Honorable Mention. Contest awards provided by the Kaethe Mela Family Memorial Fund of the Jewish Foundation of Memphis. Kaethe, her husband Paul and their 17-year-old daughter Doris, lost their lives in Auschwitz.
- 13) First Place essay will be published in the program booklet for Memphis Jewish Federation's annual community-wide Yom HaShoah/Holocaust observance on Tuesday, April 14, 2025.

 All winners will be officially recognized at the commemoration.
- 14) Winning essays will be published in print and digital publications.
