# IF YOU TEST POSITIVE

AND DO NOT HAVE SYMPTOMS

### IF YOU HAVE BEEN AT THE JFGNH/JCC

### **ANYTIME DURING THE PRECEDING 14 DAYS:**

- NOTIFY YOUR MANAGER AND/OR THE CEO OR JCC EXECUTIVE DIRECTOR
- The Director of the area that was visited will be notified to ensure proper cleaning protocols are followed.
- Do not come to the JFGNH/JCC campus during time of isolation (at least 10 days).
- The CEO or JCC ED will identify all individuals who are confirmed to have had a significant exposure to you.
- Those persons who are identified will be encouraged to reach out to a medical professional for further evaluation.
- Exposed individuals will not be permitted to reenter the JFGNH/JCC campus for a period of at least 14 days from the time of last exposure.

# IF YOU TEST POSITIVE

AND <u>HAVE</u> SYMPTOMS

#### IF YOU HAVE BEEN AT THE JFGNH/JCC ANYTIME

#### **DURING THE PRECEDING 14 DAYS:**

- NOTIFY YOUR MANAGER AND/OR THE CEO OR JCC EXECUTIVE DIRECTOR.
- The Director of the area that was visited will be notified to ensure proper cleaning protocols are followed.
- Do not come to the JFGNH/JCC campus during time of isolation (at least 10 days), until there is no fever for 24 hours, and there has been improvement of symptoms. For those who have had severe illness or are severely immunocompromised, that recommended duration of precaution could be longer, and should be determined by the treating provider.
- The CEO or JCC ED will notify all individuals who are confirmed to have had a significant exposure to you.
- Those persons who are identified will be encouraged to reach out to a medical professional for further evaluation.
- Exposed individuals will not be permitted to reenter the JFGNH/JCC campus for a period of at least 14 days from the time of last exposure.

ONLY THE CEO OR JCC EXECUTIVE DIRECTOR HAVE THE AUTHORITY TO COMMUNICATE THE IMPACT OF THE EXPOSURE OF THE COVID-19 INDIVIDUAL ON THE JFGNH/JCC CAMPUS, INCLUDING INTERRUPTION OF SERVICES, DETAILS OF CIRCUMSTANCES, AND TIMEFRAME FOR REOPENING, TO THE JFGNH BOARD, JCC BOARD, STAFF, MEMBERSHIP, BEVERLY LEVY ELC FAMILIES AND/OR THE COMMUNITY
