Policy Review & Agreement

MAKE-UP AND REFUND POLICY

Lessons must be cancelled by 9:00 a.m. the day of the lesson to qualify for a make-up class. Make-up's are limited to one per month and are valid for one calendar month from the date of the cancellation, as long as you are currently enrolled. There is absolutely no rescheduling of make-up lessons.

In the event of an extended swimmer illness or serious swimmer injury, when a swimmer is unable to continue participation in the program, it is the participants' responsibility to bring a written doctor's note within 3 days of the injury or illness in order to potentially qualify for a refund or credit. All refund and credit requests must be submitted in writing to the administration. Please note that there will be a \$25 administration fee for processing refund/credit requests. Credits and refunds will be made at the discretion of the administration. A swimmer will be considered absent from a program until a written withdrawal notice is received.

No other fees, charges, assessments, or other amounts paid to Shorefront Y are refundable under any circumstances.

CANCELLATIONS/TERMINATIONS

In order to discontinue class(es), you must complete and submit a *Lesson Termination Form* at the front desk. All cancellations must be made before the 1st of the following month in order not to accrue penalty. If the cancellation is done on the 1st of the month or after, you will be responsible for a late cancellation fee of \$25.

If you need to discontinue classes before the end of the month any unused paid amount will remain, net \$25 cancellation fee. Any unpaid balance will be your responsibility as well as \$25 cancellation fee.

The Shorefront Y reserves the right to cancel a program due to low enrollment or cancel classes in the event of inclement weather, unavailability of an instructor (in the absence of a substitute) and any situation as deemed urgent by the administration or government mandate. Every attempt will be made to inform registrants of class cancellation. If a program is cancelled due to low enrollment, a credit will be issued for the number of classes cancelled. We will make every effort to reschedule cancelled classes depending on when they are cancelled in the season and the feasibility of providing make-ups.

The Shorefront YM-YWHA reserves the right to terminate program participation of the child who exhibits a serious and persistent behavioral pattern and may pose a risk to him/herself and/or others like improper conduct and use of equipment, and unacceptable language. An Instructor and Program Coordinator will be in communication with families of any child exhibiting problematic behaviors. No refund will be issued for termination due to behavioral issues.

LOCKER ROOM

Shorefront Y Swim participants are urged to secure their personal belongings in one of our socially distant lockers. The Shorefront Y is not responsible for any items stored in the locker room. You must bring your own lock. Children aged 6 and over must use gender-appropriate locker rooms. Appropriate sports attire is required for all classes. All swimmers must bring swimsuits, swim caps, pair of goggles, flip-flops, and a towel to each practice. Parents are also responsible for their swimmer's behavior in the locker rooms. Locker room use is a privilege and if Shorefront Y swimmers demonstrate bad behavior in the locker rooms, the Shorefront Y could take away that privilege. Consistent misbehavior in the locker room will be grounds for suspension and possibly expulsion from the team.

ANTI-BULLYING AGREEMENT

Everyone has the right to feel physically and emotionally safe at the pool. Swimmers, Parents, and Coaches will do everything they can personally, as a member of the Shorefront Y, to create and preserve a physically and emotionally safe environment. Swimmers will commit that they will not bully their peers. When bullying is witnessed, they will report it to an adult. Parents will commit to encouraging their swimmer(s) to always respect others and instruct their swimmer(s) not to bully. Coaches will commit not to bully their peers, the swimmers or parents and when bullying is witnessed, they will report it to the proper authorities.
