**Please read each policy**

- I understand that there are certain skills involved with swimming and related activities. I hereby agree to assume all liability for myself and my child(ren) while at the Shorefront Y LKSA, and I further agree to hold harmless the officers of the Shorefront Y LKSA and its employees for any complications or injuries that may result from myself or my children attending the Shorefront Y LKSA.
- Shorefront Y LKSA offers a satisfaction guarantee on all their lessons; therefore there are **NO REFUNDS FOR ANY REASON**. If I am not happy with any lesson, I will let LKSA know that day of the lesson.
- My initial payment includes an enrollment fee of \$70 per child and includes an LKSA swim cap and student progress book. For Parent-Tot students there is an enrollment fee of \$50. Both registrations receive a 40% discount off your first time purchase at lksaswimstore.com. Lost or damaged caps and books can be replaced for \$8 each. An annual registration fee of \$20 per child is due on my anniversary.
- Shorefront Y LKSA cannot guarantee the same instructor for each lesson. If my instructor is absent, another qualified instructor will be assigned. If possible, I will be notified of such changes, but LKSA cannot guarantee to do so.
- I understand that although my child may pass certain skill levels during classes, children need supervision around or near water at all times and it is dangerous to assume that any child is totally "water-safe."
- I understand that there is no free swim time during lessons. Students enter the water when called by their instructor for their lesson and exit at the end of the lesson.
- I authorize the Shorefront Y LKSA to use my e-mail and phone number to communicate any schedule updates and announcements. We will never share any client information with outside parties.

**Make Up policy**

- I understand that lessons must be cancelled by 9 a.m. the day of the lesson to qualify for a make-up.
- Make-up's are limited to one per month and are valid for one calendar month from the date of the cancellation, as long as I am currently enrolled. Lessons cancelled by LKSA are also good for one calendar month with no other restrictions.
- I understand that there is absolutely no rescheduling of make-up lessons.

**Monthly Billing**

- I understand that I am enrolling for continuous swim lessons and that my account will be automatically charged for the set monthly fee for all lessons my child/children are enrolled in during the billing month.
- I understand that in order for my credit card to be automatically charged monthly, I need to fill out a Payment Authorization Form. If one is not attached, I must request one from the office staff.
- Charges will be made on the 25<sup>th</sup> of the month (or the first business day thereafter) for the following month. I also understand that if I sign up for monthly billing after the 20<sup>th</sup> of the month, my initial payment will include a prorated amount for current month plus the fees of the next month.
- Billing is automatically prorated during any month when Shorefront Y LKSA has planned closures.
- I understand that monthly payment is due on the **first** of each month and no later than the **fifth**. There is a \$25 fee for late payment. There is a \$35 fee for any bounced check and \$5 for decline credit card.

**Termination of Lessons**

- I agree to notify the Shorefront Y LKSA by the 20<sup>th</sup> of the month in order to terminate my students' lessons for the following month. I agree to complete the "Lesson Termination Form" which is available in the Swim Academy office. My final payment will be prorated to pay for lessons up to my termination date.
- If I need to discontinue lessons, effective immediately, there is an additional \$25 cancellation fee. Any remaining charged balances will be kept in my family account until I choose to resume lessons; I may use my remaining credit for any other service we offer at Shorefront Y. The Shorefront Y LKSA does not offer refunds.
