Swim Team Policy Review & Agreement

September 2018 - June 2019

Registration and Transfers

Swim team is a 10-month program and participants are required to make a commitment for the full year. All participants will have try-outs for orientation purposes and group placement. Participants register for classes that meet on specific days and times. All courses are filled on a first-come basis. Holiday closings are included in the number of sessions and price of classes (please see holiday schedule). We strongly recommend that you register for the appropriate class at the time of payment.

Make-Up and Refund Policy

Attendance is the sole responsibility of the participants and there are no make-up practices. The Shorefront Y is not responsible for providing class make-ups, credits, or refunds for programs or classes missed as a result of illness, family emergency or other personal situations.

Swim Team fees assessed by Shorefront Y are non-refundable except under the following circumstances:

- Extended swimmer illness (defined as an illness causing the swimmer to miss swim practice for 14 or more consecutive calendar days);
- Serious swimmer injury (defined as an injury causing the swimmer to miss swim practice for 14 or more consecutive calendar days);

In the event of an extended swimmer illness or serious swimmer injury, the prorated unused portion of the affected monthly's fees will be refunded to the swimmer's Shorefront Y account. In event of injury, when swimmer is unable to continue participation in the Swim Team program, it is the participants' responsibility to bring a <u>written doctor's note within 3 days of the injury or illness</u> in order to potentially qualify for a refund or credit. All refund and credit requests must be submitted <u>in writing</u> to the administration. Please note that there will be a <u>\$25 administration fee</u> for processing refund/credit requests. Credits and refunds will be made at the discretion of the administration. A swimmer will be considered absent from a program until a written withdrawal notice is received.

No other fees, charges, assessments, or other amounts paid to Shorefront Y are refundable under any circumstances.

Cancellations

The Shorefront Y reserves the right to cancel a program in the event of inclement weather, unavailability of an instructor (in the absence of a substitute) and any facility or community situation as deemed urgent by the administration. Every attempt will be made to inform registrants of class cancellation. We will make every effort to reschedule cancelled classes if possible; however we do not guarantee that this will always be possible.

Program Cards

All swim team participants will be issued registration cards upon registration for the term of the program. They $\underline{\text{MUST}}$ present their registration cards at the security desk in order to access the facility.

Locker Room

The Shorefront Y urges participants to take advantage of our locker rooms in order to secure their personal belongings. The Shorefront Y is not responsible for any items stored in the locker room. You must bring your own lock. Children age 6 and over must use genderappropriate locker rooms. Appropriate sports attire is required for all classes. All swimmers must bring TWO swimsuits, TWO swim caps, TWO pairs of goggles, flip-flops, and a towel to each practice. Each participant must also bring their own jump rope to all dry land practices. Parents are also responsible for their swimmer's behavior in the locker rooms. Locker room use is a privilege and if Shorefront Y swimmers demonstrate bad behavior in the locker rooms the Shorefront Y could take away that privilege. Consistent misbehavior in the locker room will be grounds for suspension and possibly expulsion from the team.

Parent Visitation

Parents may be present during classes on the first day, mid-term, and final day of practices to observe and encourage their children. Parents are not allowed to be present during all other swim team practices, unless specifically invited by coaching staff.

Meet Entries and USA Swimming Registration Fees

The Shorefront Y will inform parents of upcoming meets. Each individual meet will be charged separately. Once a swimmer has been entered in a meet, the Shorefront Y cannot refund entry fees for any reason. In order to participate in the meets, the swimmer <u>MUST</u> be enrolled in the Shorefront Y Swim Team and paid in full to date. Every athlete <u>MUST</u> register with, and become a member of USA Swimming, Inc. Registration must be renewed annually by January 1st for a fee of <u>\$72</u> through the Shorefront Y. Registration includes medical accident insurance that covers the athlete at all sanctioned events and supervised practices.
